CONSIGNMENT IS BY APPOINTMENT ONLY Appointments can be made in person, by calling 617-354-3700, or by emailing cambridgeraspberrerberet@gmail.com. **There is a limit of 25 items per appointment.**

- A Raspberry Beret staff person will go through your items while you wait.
- Please allow 10 to 15 minutes for your appointment.
- Items should be folded neatly and transported in a reusable bag or suitcase. Clothing brought in garbage bags WILL NOT be accepted. _____(initial)

CONDITION OF CONSIGNMENT All clothing must be in new or like-new condition.

- Clothing should be in current and/or upcoming season. Please refer to our website for seasonal guidelines.
- Items must be laundered before being brought in for consignment.
- Items with stains, holes, rips, missing buttons or broken zippers will not be accepted and should not be brought in for consignment.
- Items that are found to be damaged after the consignment appointment will be removed from the racks and donated to charity.
- Raspberry Beret reserves the right to refuse any item no matter the label or condition. _____(initial)

PRICING Raspberry Beret prices items at 1/3 of original retail cost for second-hand items and 1/2 for new items with tags. Items are researched prior to pricing. Pricing is not available on the spot at appointments.

- A small buyer's fee will be added to the sales price. The buyer's fee will not affect consignors's percentage.
- Items may be marked down (i.e., end of season, holiday, special events) at the discretion of Raspberry Beret. _____(initial)

CONSIGNMENT PERIOD The consignment period is 60 days.

- Items not sold during the 60 day consignment period become the property of Raspberry Beret and will be donated to charity at our discretion.
- Any item withdrawn by the consignors before the 30th day of the consignment period will incur a handling fee of two dollars (\$2.00) per item. _____(initial)

HIGH END ITEM RETURN Upon request Raspberry Beret Staff will pull unsold *high-end items* for the consignors to pick up at the end of their consignment period. This service is **only** offered for items that have been *priced by Raspberry Beret at \$50 or more*. **NO EXCEPTIONS. If you are uncomfortable with your items being donated, consignment with us is not recommended.**

- A 3 day notice before the end of your 60 day consignment period is required.
- Items **MUST** be picked up within 3 days of the requested date.
- Items not picked up within 3 days of the requested date will be donated to charity. _____(initial)

CONSIGNMENT PAYMENT Consignors receive 40% of the total earnings for their consigned items.

- Consignors are eligible for a payout check after their 60 day consignment period is over.
- Consignors are put on a payout list concurrent with their expiration date.
- Checks are written on the 15th of each month for amounts over twenty dollars (\$20) and are available at Raspberry Beret the next day during normal store hours.
- Checks can be mailed to the address provided below, for \$.50, and are posted on the 20th of each month.
- Consignors may use the money they earn as store credit and will get a 15% discount when they do.
- Consignment payment is available by check for up to six (6) months after accrual and by store credit for up to eighteen (18) months accrual.
- Checks not picked up after six (6) months become the property of Raspberry Beret. _____(initial)

Raspberry Beret shall NOT be responsible for loss or damage to items consigned for any reason including theft, fire, vandalism, or natural disaster. By signing below, you acknowledge, understand, and agree to all terms of this contract.
